REPORT ON THE WORK OF COURTS IN THE REPUBLIC OF SERBIA FOR THE PERIOD JANUARY - JUNE 2019

The judicial power is unique, courts are independent and autonomous in their work and they adjudicate in accordance with the Constitution, laws and other general acts, when it is stipulated by the law, generally accepted rules of international law and ratified international treaties.

I

INTRODUCTION

Courts are independent and autonomous state authorities that protect freedom and rights of citizens, legally-set rights and interests of legal entities and ensure constitutionality and legality.

Courts in the Republic of Serbia are courts of general and special jurisdiction.

Courts of general jurisdictions are: basic courts, higher courts, appellate courts and the Supreme Court of Cassation.


Courts of special jurisdiction are: commercial courts, Commercial Appellate Court, misdemeanor courts, Misdemeanor Appellate Court and Administrative Court.

The Supreme Court of Cassation is the highest court in the Republic of Serbia and it is directly superior to the Commercial Appellate Court, the Misdemeanor Appellate Court, the Administrative Court and appellate courts.

In addition to the Supreme Court of Cassation, the Commercial Appellate Court, the Misdemeanor Appellate Court and the Administrative Court are republic-level courts.

As of January 1, 2014, in the Republic of Serbia there is the total of 159 courts, of which 66 courts act as basic courts, 25 as higher, 16 commercial, 44 misdemeanors and the Administrative Court, which act as first instance courts. Higher courts act as second instance courts, as well as 4 appellate courts, Commercial Appellate Court and Misdemeanor Appellate Court.

On the territory of the AP Kosovo and Metohija three courts operated until adoption of special regulations: Misdemeanor Court in Kosovska Mitrovica, Higher Court in Kosovska Mitrovica and Basic Court in Kosovska Mitrovica.



According to the data of the High Court Council, in the first half of the previous year, the total number of all judicial positions in all courts in the Republic of Serbia, determined by the Decision of the High Court Council, was 2,995, of which 2,583 positions were filled, while 2,482 judges were effectively working.

At the end of 2018, out of 2,999 judicial positions, 2,588 positions were filled, while 2,418 judges were effectively working.

Pursuant to the Decision of the High Court Council, in the first half of 2019, the total number of all judicial positions in all courts in the Republic of Serbia was **3,019**, of which **2,735** positions were filled, while **2,538** judges were effectively working. Compared to 2018, the number of filled judiciary position grew, but there are still **284** judicial positions not filled in the court system, resulting in reduced efficiency of the overall judicial system in the Republic of Serbia.

According to the above indicators, the judicial system is still characterized by inadequate number of filled open positions compared to needs, especially if increased number of inflow cases is taken into consideration.

The average age of judges in Serbia has increased to 54; there is the total of 776 male and 1,959 female judges. There are 323 judges that are 40 years old or younger, 751 judges between 40 and 50, 1,192 judges between 50 and 60 and 469 judges that are older than 60.

The unfavorable age structure of judges in Serbia should be resolved through future systemic solutions and timely filling of vacant judicial positions, in order to ensure professional and experienced continuity in conducting the judicial functions.

According to the data of the High Court Council, there was the total of 10,618 court staff working in the court system and their average age was 44. Of that, there were 1,595 judicial assistants, 5,851 civil servants and 3,172 general service employees.

In the first half of 2018, there were 1,725 judicial assistants, but in the first half of 2019, this number dropped to 1,595, additionally reducing efficiency of performance of judicial function, in particular in terms of preparation of draft court rulings, which renders the work of judges on individual cases easier.

According to the 2019 Budget Law, all courts are financed from the budget in the overall amount of RSD 24,506,060,000.00. Compared to the total 2019 budget of the Republic of Serbia which was RSD 1,269,091,337,000.00 the expenditures for courts accounted for 1.93%, while the amount of RSD 533,607,000.00 was allocated to the Supreme Court of Cassation.

II

DISPOSED CASES

During 2018, all courts in the Republic of Serbia disposed **2,298,870** cases.


In the first half of 2019, all courts disposed the total of **1,145,268** cases, compared to **1,145,770** cases disposed in the same period in 2018.

Comparing the first half of 2019 with the first half of 2018, approximately the same number of cases was disposed.

In addition, in the observed period January – June 2019, basic courts also disposed 210,738 cases upon requests of citizens for verification of signatures, manuscripts and transcripts, issuing certificates, etc. which are not shown in the tables in the Report, while higher courts had the total of 8,069 of such cases. In misdemeanor courts, the total of 423,921 cases were disposed that are not shown in the tables in this report, for these special courts. Court administration handles these cases, under the supervision of court presidents and/or judges, and they account for additional 642,728 cases that the courts disposed.

In the period January – June 2019, public notaries handled the total of 41,266 (32,032) cases related to death certificates and additional 37,156 (35,746) cases regarding probate proceedings i.e. 78,422 (67,778) cases in total.

In the period 01/01 - 30/06/2019, the highest number of cases was disposed by basic courts -534,556 and misdemeanor courts -324,944 cases.

The above data show that there is an increasing trend of the number of disposed so-called trial cases in the first half of 2019, without taking into account enforcement cases, representing a positive progress compared to the previous period, achieved thanks to the better organization of operations in courts as well as increased efforts made by judges in resolving repetitive cases and more efficient harmonization of the jurisprudence.

At the same time, the Supreme Court of Cassation in cooperation with the Ministry of Justice has developed electronic forms upon initiative of higher and appellate courts, aimed at generating rulings by AVP and SAPS programs, which are intended for standard cases in which the Republic of Serbia – Ministry of Defense has withdrew lawsuit i.e. admitted the claims submitted by reservists, in order for judges to disengage from drafting some rulings and commit themselves to resolving the most complex cases.

INCOMING CASES IN THE FIRST HALF OF 2019

Comparative data on incoming cases in all courts in the Republic of Serbia indicate a significant increase of influx as of 2015, the trend which continued in the first half of 2019.





Increased inflow of incoming trial cases is particularly pronounced in Belgrade basic courts, the Belgrade Higher Court, which needs to be strengthened both in terms of staffing and the number of judicial assistants, since the judges of that court in the second-instance civil matter handle the highest number of such cases, and the delegation of cases to other higher courts in the Republic does not represent a more permanent systemic solution.

Increased inflow cannot be overcome in other courts without filling vacant judicial positions in a timely manner and hiring more court assistants and other court staff to handle cases, especially given the continued ban on employment in the courts. The number of administrative

staff in courts does not match professional needs of the court staff handling the cases and assisting the judges in their work, which is why it is necessary to analyze the real structural needs of the court staff and judicial assistants, which should enable more efficient work of judges on individual cases.

The largest increase in inflow occurred in cases of protection of right to trial within reasonable time. In the first half of 2018, the total of 32,894 such cases was received, while in the first half of this year, this number grew to 48,987. The number of cases on claims for compensation of non-material damages for violation of the right to trial within reasonable time grew from 5,819 to 10,561 in the first half of 2019 as well as the number of cases for compensation of material damage on the same bases from 767 to 4,416. The increased number of cases regarding protection of the right to trial within reasonable time relates to the enforcement of final court decisions against socially-owned companies, that were suspended by the Privatization Law, to which the courts had no influence nor did the privatization proceeds flow into the court budget, while now the damage is paid out form the proceeds earmarked for the work of the courts, and the obligations of the insolvent socially-owned enterprises are transferred to the state. Therefore, criticism that court proceedings are unreasonably long due to the court inefficiency cannot be accepted without reservations.




Chart 4 Prr –cases regarding claims for compensation of non-pecuniary damages for the violation of the right to a trial within reasonable time

PENDING CASES ON JUNE 30, 2019

Comparative indicators for the period 2012 – 2018 indicate a significant decrease in the number of pending cases in all courts in the Republic of Serbia, so in comparison with 2012, there are 1,456,820 fewer pending cases (reduction from 3,158,400 to 1,701,580 pending cases at the end of 2018).

At the end of the first half of 2019, there were **1,639,846** pending cases, so the total number of pending cases in the Republic of Serbia dropped in all matters.







After quite some time, in the first half of 2019, the total number of pending cases in all matters in Serbia was reduced; the same result was achieved in the category of the number of pending cases – excluding enforcement cases, as well as the total number of enforcement cases based on the writ of execution "I" and on an authentic document "Iv" in basic courts, while the total number of enforcement cases in commercial courts was halved.

VI

BACKLOG CASES

The Amended Single Backlog Reduction Program of the Supreme Court of Cassation, dated August 10, 2016, with the validity period extended until 2020, envisages systemic, general, special and individual measures for reduction of backlog cases, that are supposed to be undertaken by the Supreme Court of Cassation, the High Court Council and the Ministry of Justice in order to ensure trials within reasonable time and accomplish envisaged objectives by 2020 by matters and, in particular, to resolve all backlog cases that are considered to be particularly urgent.

Through the implementation of these strategic documents, the Supreme Court of Cassation shows in this report the number of pending backlog cases i.e. cases in which the proceedings last more than two years from the date of the initial act.

Thus, at the end of 2012, in all courts in the Republic of Serbia there were 1,729,768 cases over two years old, while at the end of the first half of 2019 there were 732,991 cases in which the proceedings lasted more than two years from the filing of the initial act. If backlog cases would be defined as those lasting for more than three years without being validly terminated, the number of backlog cases would be halved. However, there are almost a million of backlog cases less than in 2012 in the Republic of Serbia, thanks in particular to systematic measures envisaged by the code of enforcement proceedings initiated by the Ministry of Justice and implemented through the EU JEP Project, in cooperation with the Supreme Court of Cassation.





Although the number of unresolved backlog cases has been reduced, the increased inflow since 2015, when 400,000 more than planned cases were entering into the court system every year, could not be overcome, especially due to the insufficient availability of court positions; therefore the number of old cases in the first half of 2019 is slightly higher than in the same period last year. However, the results of 2018 and the first half of 2019 indicate that the influx of new cases will be cleared and the number of backlog cases reduced, especially given the announced systemic measures by the Ministry of Justice, to further improve the enforcement system.

VII

DISPOSED BACKLOG CASES

In the period January-June 2019, the total of **1,145,268** cases were disposed in all courts in the Republic of Serbia, of which **148,271** were backlog cases i.e. cases older than two years calculating from the date of the initial act.













Having in mind the objective stated in strategic documents of the Supreme Court of Cassation by 2020 i.e. to dispose all criminal cases, the procedure of which lasts over five years or all civil cases, the procedure of which lasts over ten years in courts in the Republic of Serbia, it should be also mentioned the following:

- there are 1,351 (P-civil litigation cases), 229 , P1" and 1 , P2" cases lasting over ten years in basic and higher courts in Serbia,;
- there are 138 "K" cases (first instance criminal cases) lasting over ten years in basic and higher courts in Serbia,;
 - there is a total of 1,719 cases that judges can dispose within the above period.

It should be noted that five higher courts (Kraljevo, Vranje, Zaječar, Pirot and Sombor) and five basic courts (Požega, Dimitrovgrad, Senta, Subotica and Šid) do not have such cases at all. Some courts have only one such case (Negotin, Bor, Valjevo, Kruševvac, Požarevac, Veliko Gradište and Prokuplje); courts in Jagodina, Užice and Petrovac na Mlavi have two such cases. The results are much better compared to the previous years, since there is a growing number of courts without such cases.
